**Sastanak Radne grupe za ruralnu arhitekturu ECOVAST-a, Ustek, 15. svibnja 1992.**

**A meeting of the ECOVAST working group on rural architecture, Ustek, 15 May 1992.**

Sastanak Radne grupe za ruralnu arhitekturu, na kojemu je sudjelovala Darja Radović iz Instituta za povijest umjetnosti, završio je izglasavanjem četiriju rezolucija, od kojih se dvije odnose na Hrvatsku, jedna na Bosnu i Hercegovinu i jedna na Češko-Slovačku. U sastavljanju rezolucije o Hrvatskoj uz predsjednika radne grupe Johna Sella sudjelovali su Jane Wade, Angus Fowler, Davor Salopek, Zdravko Živković i Darja Radović. Te rezolucije obvezuju prisutne stručnjake ECOVAST-a da pomognu Hrvatskoj u budućoj obnovi i u svim problemima koje će ona obuhvaćati.

*The meeting of the working group on rural architecture, in which Darja Radović from the Institute of Art History took part, ended with the passing of four resolutions - two referring to Croatia, one to Bosnia and Herzegovina and one to Czechoslovakia. The resolutions relating to Croatia were framed by the chairman of the group, John Sell, along with Jane Wade, Angus Fowler, Davor Salopek, Zdravko Živković, and Darja Radović. These resolutions commit the ECOVAST experts who were present to assisting Croatia in the future restoration of the country and all the problems that this will involve.*

Resolutions passed at Ustek meeting, 15th May 1992

RESOLUTION NO. 1

We deplore the deliberate attacks on historic monuments in Bosnia-Herzegovina. This is the third republic in the former Yugoslav state to be under attack by the same aggressor within the year. The pattern of attack is deliberately destroying cultural identity. Sites of European importance are under attack, particularly buildings displaying the sign of the Hague Convention, centres of small historic towns and villages.

Bosnia has a diversity of cultures and religions; people have lived in harmony for years until the recent deliberate agitation. This rich heritage should not be destroyed nor its people have to desert their homes.

RESOLUTION NO. 2

We call upon European Governments and institutions to give every assistance to Croatia in repairing war damage to its historic buildings, small towns and villages. Such assistance should be help with recording historic buildings, providing documentation and providing funds for repair and reconstruction.

RESOLUTION NO.3

We resolve that the Rural Architecture working Group of ECOVAST will use its network of contacts to:

1. disseminate knowledge of the war damage in Croatia as widely as possible
2. identify sources of conservation skills which are needed for the reconstruction and repair of war damaged historic buildings, small towns and villages
3. warn of the danger of too hasty reconstruction and redevelopment and try to ensure that reconstruction will only take place after very careful consideration
4. ensure the co-ordination of professional international assistance
